RULE AND CONDITIONS:

1. GoBus must be notified at least 24 hours in advance that an unaccompanied child will be riding with us by calling 888-954-6287 Monday through Friday between 8:00am and 4:00pm.
2. An Unaccompanied Child Form must be filled out and signed by the child's parent / guardian. A form must be filled out for each child traveling and for each travel date. The form can be emailed (info@RideGoBus.com), faxed (740-767-2301), or mailed (GoBus PO Box 220 Glouster, Ohio 45732) to GoBus in advance or can be handed to the driver as the passenger boards the bus. Each child traveling needs have a copy of this form with them during their travels.
3. It is against GoBus and Barons Bus policy to carry children under the age of 12 unless they are accompanied by another passenger at least 17 years of age or older. Exception may be granted on a case by case basis.
4. Unaccompanied children between ages of 12 and 16 may travel unaccompanied provided the parent or guardian has provided an Unaccompanied Child Form. The Unaccompanied Child Form must be completed in its entirety.
5. The child shall comply with any reasonable instruction from GoBus and its employees, necessary to the child's safety and well-being and the proper conduct of the journey.
6. Should the child become ill en-route, the Company reserves the right to take whatever action it deems necessary to ensure the comfort and safety of the child. All costs associated with such action will be borne by the child's parent/guardian.
7. The child must travel with sufficient food and/or adequate funds for meals en-route.
8. GoBus and/or Barons Bus shall not be responsible for any loss or damage incurred by the child as a result of late boarding or failure to board, either at the initial boarding point or at any intermediate stopover point.
9. The parent/guardian/adult responsible for collecting the child at the pick-up point must be at the stop 20 minutes before the expected arrival time according to the timetable.
10. The parent/guardian/adult responsible, described above, shall meet the unaccompanied child at the destination; and satisfactory proof of identity must be produced. They must have proof of identity must include photo identification and can be in the form of driver's license, passport, over 18 card, or similar.
11. GoBus will only disembark the child at a scheduled stopping point as detailed in its official timetable or any amendments thereto from time to time in force.
12. The only exception to clause 11 is if the person responsible for the child is not present when the coach arrives at the child's drop off point and contact cannot be made with either the guardian/parent and/or the persons responsible for the child at the pick-up point. In this circumstance, the child will be taken to the nearest police station.
13. GoBus, Barons Bus, and its employees will accept no responsibility for unaccompanied children whilst in transit; however all care will be exercised where possible.
14. These conditions shall be read in addition to GoBus's standard conditions of carriage and shall in no way alter, waive or modify those conditions.

In consideration of GoBus agreeing to carry the passenger described above (being an unaccompanied minor), I accept and agree to the Rules and Conditions outlined above and hold GoBus and Barons Bus indemnified against any loss or damage it is or may be liable for as a result of any act of omission or commission by the passenger.
